2. Public Hearing to Entertain Comments Pertaining To The Findings Deeming 5888 State Route 15A Unsafe

*Mr. Steve Licciardello was in contact with the CEO regarding the overgrown brush around the structure. He has had issues with someone repeatedly breaking in and leaving trash. Mr. Licciardello also has contacted at least six contractors regarding having the foundation repaired and has not received any return calls. He felt he has been in contact with the CEO and did not understand why he received the resolution. *CEO Smith indicated several violation notices have been mailed to Mr. Licciardello with no return contact. *Councilman O'Connor mentioned that having break-ins leaves Mr. Licciardello vulnerable if anyone is hurt on the property. The break-ins would have to be addressed by contacting the Ontario County Sheriff's office. The Town's concern is the walls that are caving in and foundation issues. The area has to be secured to keep anyone from getting near any of this area. Councilman O'Connor felt additional time should be allowed until the next meeting to secure the structure.

*Mr. Licciardello questioned what the Town's definition for the next step or actions would be. Councilman O'Connor indicated the town would go out to bid for a company to demolish the structure and the cost would be added to the town and county tax bill. Mr. Licciardello doesn't feel it needs to get to that point and feels it can be repaired. The current conditions with pricing for building materials makes it cost prohibitive for repairs. He will secure the structure/property and put posted signs up.

*It was suggested the CEO and Mr. Licciardello meet before June 10th to discuss what might secure the structure/property.
