E. BUDGET REVIEW:

- *Supervisor Singer provided the Board with a proposed 2021 preliminary budget and proceeded to go through the proposed budget highlighting any changes or reductions.
- *Wages the percent of change column is not currently showing the correct amount in the proposed budget, there is an error in the program. Wage increases: for Highway 2.5%, most salaried positions 2.5%, hourly wage positions will be increased \$.66 cents. The Supervisor, Justice, Budget Officer and Bookkeeper to the Supervisor will be increased 1%.
- *The Planning and Zoning members will receive \$40 per meeting.
- *The CEO requested an increase in hours for the Deputy CEO from 10 hours to 16 hours a week.
- *Discussion took place regarding the requested 2% for the Honeoye Public Library.
- *A budget request would be needed for Little Lakes Community Center before anything might be granted.
- *Some discussion took place regarding the RFP information for a new HVAC system.
- *Supervisor Singer will make the adjustments discussed by the Board and print the revised 2022 preliminary budget.

WHEREAS, this Board wishes to renew the agreement with the Hemlock Fire District for one-year commencing January 1, 2022 and terminating on December 31, 2022 for compensation in the amount of \$23,138; and

WHEREAS, this Board wishes to renew the agreement with the Richmond Fire District for Ambulance service for the entire Town of Canadice and Fire Protection Service for all areas except those covered by the agreement with the Hemlock Fire District for compensation in the amount of \$177,018.00 for one-year commencing January 1, 2022 and terminating on December 31, 2022; and

WHEREAS, a Public Hearing was held on September 28, 2021 relative to the proposed 2022 Fire and Ambulance Protection Contracts; now, therefore, be it

RESOLVED, that this Board is hereby authorized to execute the fire and ambulance protection agreements with the above mentioned Fire Districts under the terms set forth in the attached documents; and, be it further

RESOLVED, that both Fire District representatives and this Board agree to review the boundary lines currently established and amend the contracts if necessary; and, be it further

RESOLVED, that the Clerk of this Board send a certified copy of this resolution along with two signed copies of each agreement to the respective Fire Districts to be signed by their Commissioners, one copy to be retained by the District, the other to be returned to the Town Clerk of the Town of Canadice.

2. **Resolution Number 55 of 2021** – Setting Date, Place and Time For A Public Hearing Pertaining To The 2021 Special Assessment Roll To Collect Water District No. 1 Capital Improvement Costs Based On Benefit Formulas
