### F. Old Business -

- 1. Turtle Rock Course The preliminary review was re-opened for the Turtle Rock Rope Course.
- The applicant is proposing a shuttle van to transport clients across the road. It was noted that the variance that was granted for the driveway was for emergency vehicles only. After review of the variance that Ms. Crane received for the driveway, it was determined that there were no restrictions as far as the type of vehicle that could use the driveway. Therefore, the proposed use of a shuttle vehicle in the driveway would be permissible.
- There was a brief review of the concerns that have been discussed in earlier meetings.
  Specifically several board members had concerns about the safety of visitors and

customers as they crossed back and forth on County Rd. #36, with traffic speeds of 55-60 miles per hour, either with a crossing guide or in a van.

Mr. Johnson motioned, seconded by Mr. Kane to grant preliminary approval for the Turtle Rock Rope Course with the provision that a shuttle vehicle is used to transport customers across the highway to the rope course. (2013-47)
