PUBLIC HEARING - FREEMAN

Vice Chairperson, Diane Horning called the meeting to order at 7:30 p.m.

Vice Chairperson, Diane Horning introduced the Zoning Board of Appeals

members and stated that a quorum was present to hear the application. The criteria, which the

Zoning Board of Appeals uses to make decisions regarding an area variance, were reviewed.

Whether an undesirable change will be produced in the character of the neighborhood or a detriment to nearby properties will be created by the granting of the area variance.
 Whether the benefit sought by the applicant can be achieved by some other method feasible for the applicant to pursue other than an area variance.
 Whether the requested area variance is substantial.
 Whether the proposed area variance will have an adverse effect or impact on the physical or environmental conditions in the neighborhood or district.
 Whether the alleged difficulty was self-created, in which consideration shall be relevant to the decision to the Board of Appeals but shall not necessarily preclude the granting of the area variance.

Vice Chairperson, Diane Horning then read permitted action for the Zoning Board of Appeals.

- D. Horning Steve can you tell us what Mr. Freeman is asking for?
- S. Smith Yes. Mr. Freeman is asking for a 9ft. area variance, the set back is 10ft. He is asking for a 1ft. set back on the north side of his property.
- D. Horning Mr. Freeman, can you explain what you are doing?
- J. Freeman I want to put up a storage shed, so we can put our kayaks in it, picnic table, grill, etc. So it is under cover when we are not there for the winter.

- E. Bott This is the only building on your property, right?
- J. Freeman Yes, but there is nothing there now.
- E. Bott You had an 8 X 8 shed before?
- J. Freeman Yes.
- E. Bott It was sitting right on the line, if I remember correctly.
- J. Freeman Yes, it was right on the line. I talked to the neighbor a couple weeks ago and she asked if I was going to move it and I said yes, a foot. She was in agreement with it when I talked to her.
- E. Bott The only reason they want you to be away from the side, is in case of a fire and you don't want to impede on your neighbors property. There was already a shed right on the line in this case. A 12 X 12 is not going to be like a full building, even if it did catch fire. That's why they have a 10ft. set back on both sides, so there would be 20ft. between houses. This is not a house.
- D. Horning Do any of the Board Members have any questions?
- M. Gascon You haven't changed anything since the last meeting?
- J. Freeman No, just waiting.
- E. Bott asked Mr. Craig if he had any questions. No questions.
- E. Bott made a motion to close the Public Hearing, R. Boone seconded, all in favor. Public Hearing was closed at 7:35 p.m.
- E. Bott explained the two step process of the Public Hearing to Mr. Freeman.
- E. Bott made a motion to accept the application as it stands, seconded by M. Gascon, all in favor.
- D. Horning Now, we vote on the variance.
