An extensive list was drafted for Ms. Crane of items that would need to be addressed. Additional meetings with Ms. Crane will take place in between the Planning Board meetings in order to keep the project moving forward. Councilman O'Connor questioned the need for handicap parking spots and if any spots would really be used due to the topography of the property. Mr. Mayhood indicated it's an ADA requirement.

Ms. Crane indicated the hunters are bringing in bottled water, the water system has been drained for the season and there are composting toilets. She is not charging hunters for a cabin if they choose to use one and they may not.

- 2. County Road 36 Flooding at Ranch Road- Supervisor Singer indicated a Notice of Claim was filed from California Ranch Properties with Ontario County.
- 3. "Welcome" Signs Already discussed.
- 4. Water District: Surveyors are still at work for the Water District and a possible property for the water tank is still being discussed. Councilman Malmendier indicated National Fuel is holding a meeting December 9<sup>th</sup> and at this time the topic of a possible construction project in Canadice is on their agenda.
- 5. Councilman Malmendier questioned if the employee handbook is still on the back burner. Supervisor Singer indicated nothing additional has taken place. Councilman Malmendier also asked about Don Cook's inquiry from last month's meeting Supervisor Singer is planning on getting information from Richmond.
- 6. Councilman Malmendier would like to propose closing the seasonal section of Holmes Road; between Canadice Lake Road and the first house west of County Road 37 on Holmes Road. There were two drums of a substance (labeled lubricating oil) dumped in the gulley along that seasonal section. DEC has removed the drums and will be investigating the issue. It's usually construction debris or tires that are dumped. Superintendent Virgil indicated they do minimal maintenance, but he doesn't have a problem with closing

that section after discussing the issue with Councilman Malmendier. Councilman Hershey indicated the Town would still have Burch Hill Road and Johnson Hill Road for east – west travel. He would recommend removing the culverts if that section is closed. Supervisor Singer will review the procedure for abandoning a section of the road with the attorney.
