- b. Took the rubber-tired excavator and backhoe around town cleaning leaves and debris in ditches and around driveways.
- c. Our intern from last year, Evan Earle, will be with us again for two weeks to learn different jobs the Highway Department takes care of. He has been a good worker and hopefully we will have a place for him in the future.
- d. The NYS Budget approved \$60 million dollars extra in the CHIPS funding and Canadice will receive approximately an additional \$16K.
 - e. Mrs. Moorhouse complimented the Highway Department on their work.
 - f. Tim Harezga is back for the summer. Fixing defects to shoulders and trimming brush.
- g. Councilman Statt questioned if we are full in our salt barns. Superintendent Fraim indicated we used more this season than last season due to ice conditions. We have a decent amount to start the next winter season. The materials have increased in cost substantially.
- 7. Honeoye Lake Watershed Research Task Force- Councilman Gronwall.
 - a. The written report for the month of April was submitted (see T.C. file).
 - b. The annual roadside trash cleanup day was successful.
- c. Honeoye Lake level has still been very high, and it's not usually this high this long. Councilman Gronwall contacted the Ontario County Sheriff's office to recommend that his department post "No Wake" signs. They were posted the following week at the Honeoye Lake public boat launches.
- d. Ontario County will handle the summer weed harvesting program from July 5th through August 31st.
- e. The Alum treatment DEC applied in Honeoye Lake last November will not have a maximum effect until mid-July through mid-September. Blue-green algae blooms will most likely appear in Honeoye Lake in June.
- f. Ontario County Soil & Water Conservation District released around 450 silver flies to combat the invasive hemlock wooly adelgid at the Finger Lakes Land Trust Westly Hill Preserve. The health of the native hemlock trees in the Honeoye Lake Watershed is threatened by the invasive pest. They are planning additional treatments later in the year.

 - a. The written report for the month of April was submitted (see T.C. file).
- 9. Water District Operations –

- a. Rochester Water Authority Operations Report submitted (see T.C. file).
- b. Councilwoman Crowley reported on the water sage reconciliation which shows what was pumped vs what is billed. April 21st the water tower was hit by lightning. They are using manual monitoring for now and once all the residents are back for the summer there is very little flushing needed. Supervisor Vastola commented on a situation he came across around the water tank area. A worker was checking underground and controls were open. Changes are being implemented so that doesn't happen again.
- c. The 2022 AWQR is complete and will be published as soon as Patricia Bedard gives the approval for release.
