*Mr. Ted Mayhood had a few comments/questions. Section 90-23 regarding shut-offs. The sentence indicating "when possible" – in non-emergency situations for notifications. He felt the wording should read either- no notification will take place in non-emergency situations or notification will be provided. Pg. 8 Section 90-33 water shut-offs – questioned notification going to the owner and the occupant. Supervisor Singer indicated even if we don't know the name of the occupant it gives them the knowledge their water may be turned off. Section 90-18 administration – annual inspection – who will take care of that and where will the records be kept. Supervisor Singer indicated the Department of Health requires that item and some of those pieces haven't been assigned yet.

- b. CEO Smith introduced the new Deputy CEO Richard Joki. CEO Smith also is requesting a laptop for their office so they can be more productive when they are both in the office.
- 4. Planning Board- Mr. Theodore Mayhood.
 - a. Draft minutes were submitted to the Town Board (see T. C. file).
- b. From the county report, the Town of Naples will be combining their town and village planning boards and zoning board of appeals into one planning board and one zoning board of appeals.
- c. There were two site plans for preliminary review. Both are in the Honeoye Lake-shore District: the Fagans on Pickerel Point and the O'Learys on Sunset Drive. They are demolishing their existing cottages and re-building structures over 800 square feet. Another application was just submitted and will be on the next agenda for preliminary review.
 - d. The Planning Board is still looking for an alternate member.

- 5. Zoning Board of Appeals- Mrs. Linda Moorhouse.
 - a. Draft minutes were submitted to the Town Board (see T. C. file).
- b. Councilman Malmendier commented for the benefit of both the ZBA and Planning Board. In the ZBA minutes there was mention of the engineering plans for the water district and set-backs. Be careful if referencing the LaBella drawings, they are not survey maps and may not be precise enough for what is being discussed. In the future, encroachment on the water district easements will have to be considered also.

 - a. The written report for the month of July was submitted (see T. C. file).
 - b. Two significant rain storms occurred in two different areas of town.
 - c. Second round of roadside mowing is taking place.
 - d. All the culverts are done on Purcell Hill Road.
 - e. The new radios are ordered.
- f. All the paperwork has been submitted to Matt Nelligan, Senator Funke's Chief of Staff, to fund the construction of the equipment storage building. It could take 12 to 24 months before the money is received.
