### C. PRIVILEGE OF THE FLOOR:

- 1. Wendy Krause, Director of the Honeoye Public Library addressed the Board. The Performances at Honeoye Lake had great attendance this past summer and Mrs. Krause thanked the Board for their contributions over the last 15 years. There are 437 residents of Canadice that have Honeoye Public Library Cards and the 2016 budget request is a 2% increase or an increase of \$465. The trustees will be holding two meetings at the Library to discuss long range plans or ideas can be dropped off at the library. Mrs. Krause will check back to find out when the budget workshop is.
- 2. Mr. Tim McAuliffe gave a report to update the Board on the Francis Shores project. A culvert is being replaced at the bottom of the road by Rick Belcher on October 15<sup>th</sup> and is totally funded by the Francis

Shores Association. The second project is the ditch on County Road 36 and down through Twin Bay. They have been working with DEC, Soil & Water and Army Corps of Engineers. Last week the project was rejected and they have to change the pipe size; the proposal was to use 24" and had to change it to 36". Mr. McAuliffe is checking to see if there is any trickle down of funds for repairs or if they can purchase stone at the Town's rate to allow them to complete the project. Supervisor Singer indicated the \$100,000 promised by Senator Funke could take up to a year or more before we receive it. The Town has already spent over \$150,000 for repairs. Supervisor Singer also questioned the attorney to confirm if Canadice can legally pass on our cost for materials and the answer is we cannot expend funds on private property. Councilman O'Connor questioned if any of the Twin Bay residents are contributing. Mr. McAuliffe indicated there are thirty-one families on Francis Shores and thirty are paying into the association and a road fund. The Twin Bay families are not contributing. One resident helped put the road back together. Supervisor Singer indicated as much as the Board would like to at least help with the stone, they are not legally allowed to and commend the association on the efforts they are making.

3. Mrs. Herbison asked if the Town can install a "No Outlet" sign at the end of their road, or if the residents can install a sign. Supervisor Singer indicated Canadice would only install a sign on a town road, not a private road.
