- 2. Little Lakes Community Association Inc.

*Bonnie Sykes, Vice President of the Steering Committee, addressed the Board to provide an overview of the Little Lakes Community Association, Inc. The group applied for and received 501(c)(3) status. A corporation was legally formed with a Board of Directors and by-laws were adopted. Their goal is to serve the towns of Livonia, Canadice, Conesus, Springwater and Richmond including the Hamlet of Honeoye and the community of Hemlock. Visitors to the region and the members of the communities previously mentioned would be able to take advantage of the space at the old Hemlock School/Jack Evans Community Center. Their mission is to restore and preserve the Hemlock School, to build community and welcome

visitors to the treasures of the Little Lakes. Their vision was to establish the association for the charitable purpose of providing benefits to residents and visitors of the Little Lakes Region of NYS, specifically Conesus, Hemlock, Canadice and Honeoye Lakes. The goal is to create an inviting and energetic place where people throughout the area can come together to learn and share knowledge while promoting activities to enhance the quality of life. They will work together to strengthen the community while supporting, promoting and collaborating with local entities as they restore the Hemlock School using sustainable technology in a manner that supports the environment. They are requesting the Town of Canadice consider budgeting \$2,400 for the 2018 fiscal year to support this project. Their goal is to approach each of the aforementioned town boards with a similar financial request. A list of volunteer work already completed and an events time-line of previously held social occasions were included with their request. Ownership of the building is scheduled to transfer/close in May of 2018 from the Town of Livonia to the Little Lakes Community Association, Inc. The Town of Livonia will deduct the cost of maintenance and repairs the association has already incurred from the purchase price. It is expected to be a cost of approximately \$5,000 for the purchase of the building and property. The building is 16,000 sq. ft. and there are approximately 3 ½ acres in back that could be used for an athletic field. There is interest in having basketball practice in the building. The Steering Committee has been approached for all types of uses for the building. Mrs. Sykes and the Steering Committee members that attended thanked the Board for their time and consideration.
