Supervisor Singer explained the purpose of the discharge field setback variance application. The distribution system is approximately 51 to 55 feet from the right-of-way and our regulations require a setback of 80 feet. Mr. Mayhood showed a map to the Town Board he had just received from Ms. Crane indicating the proposed

location of the installation of a septic tank. The leach field is already installed. Mr. Grove, the engineer, indicates a septic tank must be installed for this project. Councilman O'Connor questioned the use of a 500 gallon tank, he was under the impression a 1,000 gallon septic tank was required. Ms. Crane indicated it's not a septic system it's for gray water only. Right now the bottom holding tank of a port-a-potty is in the main cabin and is pumped weekly and will eventually be a composting toilet. The only thing going into the "septic" tank is gray water from the showers and sinks in the main cabin. Councilman Hershey is not sure some of the engineer's statements coincide with what the NYS Department of Health requires and will check into it before the next meeting. In this situation, the slope is as important as the distance from the right-of-way. Ms. Crane indicated the slope isn't that much in the area the tank would be installed. Councilman Malmendier questioned if the other items in question for the site plan application are being addressed. Mr. Mayhood indicated the fire protection access and an updated site plan map are two of the items still needed. Ms. Crane mentioned she isn't sure what to do about the fire protection requirement. Supervisor Singer will contact Jeff Harloff, Director of Emergency Management to get his opinion.

WHEREAS, a reliable transportation infrastructure is vital for the safety of New York's traveling public and its economy; and

WHEREAS, 85 percent of New York's roads and bridges are maintained by local governments; and WHEREAS, despite well-timed and targeted preventative maintenance treatments, the age and condition of many of our locally-owned transportation assets means they are beyond preservation and in need of much more costly rehabilitation and reconstruction; and

WHEREAS, estimates by the State Comptroller, DOT and independent studies show a large portion of road mileage is deteriorating and many bridges in the state are rated structurally deficient and functionally obsolete; and

WHEREAS, the State Comptroller estimates there will be \$89 billion in unmet local infrastructure needs over the next 20 years; and

WHEREAS, the New York State Association of Town Superintendents of Highways commissioned its own 15-year analysis that indicates an annual funding gap of \$1.3 billion for the local system alone (excluding NYC); and

WHEREAS, funding for our local system has been far short of what is needed and we've fallen further and further behind in maintaining the vast and aging transportation infrastructure over this long period with severe consequences for conditions ratings; and

WHEREAS, the New York State Consolidated Local Street and Highway Program (CHIPS) provides essential funding for every municipality in the state and is part of the New York State Department of Transportation (NYSDOT) capital program; and

WHEREAS, in the early 1990's the Governor and Legislature created the Dedicated Highway and Bridge Trust Fund (DHBTF) to pay for the NYSDOT capital program and the Dedicated Mass Transit Trust Fund (DMTIF) to assist with the Metropolitan Transportation Authority (MTA) and other transit systems' capital programs; and

WHEREAS, when the DHBTF was created, it was agreed the NYSDOT and MTA five-year capital programs would be similar in size and would be negotiated concurrently; and

WHEREAS, through 2005-09, both five-year capital programs were similar in size and adopted within months of each other; and

WHEREAS, in 2010 the Executive and Legislature broke traditional parity and enacted a five-year capital program for the MTA but not the DOT; now, therefore, be it

RESOLVED, that the Town of Canadice, NY, calls upon the Governor and the State Legislature to make additional state funding and resources available at levels that accurately reflect the critical needs of local roads and bridges; and increase CHIPS funding in the 2016-17 state budget; and, be it further

RESOLVED, that the Town of Canadice, NY, calls upon the Governor, and members of the State Legislature to fully fund and submit a new NYSDOT five-year transportation capital plan; and, be it further RESOLVED, that the Town of Canadice, NY calls upon the Governor and members of the State Legislature to recognize the equality of roads, bridges and transit by restoring funding equality between the MTA and NYSDOT five-year programs and by voting on the plans simultaneously.

7. Honeoye Lake Watershed Research Taskforce- Councilman Hershey.

a. Mr. Terry Gronwall reported that Soil & Water received notice that the \$300,000 Inlet Restoration Grant was awarded December 10th. Councilman Hershey is credited with helping get this grant with the help

of The Nature Conservancy, US Fish & Wildlife and Ontario County Soil & Water Conservation District. The Nature Conservancy has committed to supplying \$50,000 of the \$100,000 of local in-kind support. The total project is estimated at \$400,000. Councilman Hershey indicated it shouldn't reach that amount in costs.

b. The HLWTF held a meeting on November 4th to discuss 2015 project updates and 2016 project plans.

c. A HLWTF fall newsletter was published in November.

d. Cornell University and FLCC have been awarded a three-year research grant to study the effects of climate warming on shallow NYS Lakes of which Oneida and Honeoye Lakes will be studied. Drs. Nelson Hairston, Cornell & Bruce Gilman, FLCC will be the main investigators.

e. Ontario County Water Resource Council will receive \$14,000 in grant funds thanks to the Board of Supervisors and HLWTF received approximately \$6,500 of that amount for water quality related projects in 2016.

8. Assessor- Mrs. Lisa M. Bennett

9. Special Reports

a. Water District – Supervisor Singer has a conference call next Monday to discuss the project. LaBella established the rights-of-way along the waterfront. They had to get some variances for stream crossings. LaBella met with MCWA regarding the master meter pit and a potential pump station in Richmond. They have been reviewing construction details and possible locations of fire hydrants. The northern long-eared bat has been added to the endangered species list so we have to coordinate with DEC and US Fish & Wildlife; they have to approve any tree cutting for the project. No property has been confirmed for the water tank yet.
