Preliminary Review – Mr. Harrison attended the April PB meeting to present his Site Plan review for his proposed new construction of a single family dwelling at 21 Vicks Place, Honeoye, NY 14471 – tax map#164.11-1-31.100. This will be a single family dwelling of approximately 1320 sq. feet, 23 ft. high one story. The existing dwelling will be demolished. Mr. Harrison has combined two existing lots for the new dwelling. Chairman Mayhood reviewed the relevant town codes. Drainage issues were discussed and Mr. Harrison indicated that swales will assist with the drainage. Steve Groet mentioned to Mr. Harrison that there is a new NYS regulation regarding the removal and

transport of construction debris, and the potential concerns associated with it. Mr. Harrison will discuss with his builder.

Mr. Engard motioned, seconded by Vice Chairman Vastola, and it was unanimously carried to grant preliminary approval for the Site Plan application of John and Linda Harrison for 21 Vicks Place, Honeoye, NY 14471 – tax map#164.11-1-31.100. (2018 -10)
