PUBLIC HEARING – Catherine Crane

Chairperson, Linda Moorhouse called the meeting to order at 7:30 p.m. Chairperson, Linda Moorhouse introduced the Zoning Board of Appeals members and stated that a quorum was present to hear the application. The criteria, which the Zoning Board of Appeals uses to make decisions regarding an area variance were reviewed.

- Whether an undesirable change will be produced in the character of the neighborhood or a detriment to nearby properties will be created by the granting of the area variance.
 Whether the benefit sought by the applicant can be achieved by some other method feasible for the applicant to pursue other than an area variance.
 Whether the requested area variance is substantial.
 Whether the proposed area variance will have an adverse effect or impact on the physical or environmental conditions in the neighborhood or district.
 Whether the alleged difficulty was self-created, in which consideration shall be relevant to the decision to the Board of Appeals but shall not necessarily preclude the granting of the area variance.
- L. Moorhouse Steve, would you give us your input on the application?
- S. Smith The last time I talked to Cathy, the driveway was not going to be circular anymore. It was just going to be in and out.
- C. Crane They don't want us to have two spots from the road. They just want one entrance from the road. They would not allow a horseshoe driveway.
- E. Bott They, meaning the county?
- C. Crane Yes.

- S. Smith The driveway you have here now, goes right down the middle of the right of way, according to this.
- L. Moorhouse Could you show us what the difference would be?
- C. Crane They just wanted one entry off the road, that was their concern.
- E. Bott So, you have a good place to turn around?
- R. Boone So, you are still maintaining the circular part of the driveway, but there is only one entrance from the road?
- C. Crane Yes ma'am, thank you.
- E. Bott I was going to say the horseshoe thing is safer.
- L. Moorhouse It looks like there is only one now.
- C. Crane Yes, there is only one, you are right.
- E. Bott He's talking about the right of way, because the right of way goes so far back in. Part of that is in the right of way. The right of way is like 70 ft.
- L. Moorhouse Do any of the board members have any questions for Cathy?
- D. Horning I don't have any questions.

There were no questions.

- E. Bott Made a motion to accept the application, R. Boone seconded, all in favor.
- E. Bott Explained the 2 step process of accepting the application and voting on the variance to Catherine Crane.
- L. Moorhouse Since there are no changes, we can now vote on the variance.
