 - i. Mission/Purpose Statement: "Consistent with the Town's Comprehensive Plan and Zoning Code, develop recommendations related to natural resource extraction that promote and protect the rural character of the Town, and the health and welfare of residents."
- b. Natural resources working list (natural resources considered are above and below ground): water, timber, gravel, shale, gas/oil.
- 4. Plan for developing recommendations: after discussion, the following steps are proposed and will be reviewed and approved at the next Committee meeting.
 - a. Answer the question: are there useful models of how other communities have addressed the issue of natural resource extraction? Are there individuals, organizations or communities who can assist us in acquiring research, plans, codes, or legislation?
 - b. Review the Town's Comprehensive Plan and Code to identify how natural resource extraction is currently regulated.
 - c. Identify the secondary impacts of natural resource extraction (such as road use, noise, light & air pollution, etc.)

- d. Review the Town's Emergency Plan and determine potential hazards from natural resource extraction and what emergency or other services exist to prevent or remediate potential hazards.
